Brooks’ Kernville Cannery model brings back memories of town

The Kernville Cannery was built in 1896 by Daniel Kern; the town of Kernville was named after him the same year. The cannery changed hands several times, and in 1907 it became Elmore Cannery, then later Gerttula Cannery and Boat Works. Kernville no longer has its notable cannery, stores, mill, and boat works industry.

This model of the Kernville Cannery, circa 1905, was created by volunteer Gary Brooks. It won Best of Show at the 15th Pacific Model Loggers Congress in 2019. This is the second model Gary has made for the museum. The other, done last year, is a model of the Pixie Kitchen.

And now . . . your moment of history

The ocean vessel “Della” supplied goods on consignment to North Lincoln County stores from the Cloverdale Mercantile Store, owned by Charles Nelson and Charles Ray. Nelson later co-founded the town of Nelscott. Ray was the founder of Cloverdale.

The “Della” and other supply vessels were important to the history of North Lincoln County. They supplied goods to pioneers when the roads leading here were either in poor condition or non-existent, using the beach as a highway where no bridges existed.
